**SUBJECT:** Decrease in State Sales and Use Tax

Consistent with Section 27A.2.(f) of S.L 2009-451, the general State sales and use tax rate applicable to sales and purchases of tangible personal property, certain digital property, and certain services is scheduled to reduce from 5.75% to 4.75% effective July 1, 2011.

As a result, the general State and local tax rate will be 6.75% in eighty-two counties, 7% in Alexander, Catawba, Cumberland, Duplin, Haywood, Hertford, Lee, Martin, New Hanover, Onslow, Pitt, Randolph, Robeson, Rowan, Sampson, Surry and Wilkes Counties, and 7.25% in Mecklenburg County.

The tax changes need to be created in Colleague by each college. Users will need to access **TXCM – Tax Codes**, to add the new tax amounts and the dates that each change will take effect and **FLTT – File Translation Tables**, to add the new tax codes from TXCM. Certain users may not have access to FLTT, if not; contact your IT Staff for their assistance. Please review the following examples for populating TXCM and FLTT.






Users will select TXCM under the Purchasing folder.





Users may have the 6.75 percent tax on file, if so; add a new line to reflect the effective date of July 1, 2011


**Please Note depending on which county your college is located to adjust the correct sale tax.**




Once the tax codes have been added and updated, users must access FLTT.
